



**RESOLUCIÓN O N° 0370**

**MAT.:** Determina máximo de aportes de origen privado permitido, con motivo de las elecciones municipales y regionales de octubre 2024, y eventual segunda votación de Gobernador Regional de 24 de noviembre 2024.

**SANTIAGO, 29 JUL 2024**

**VISTOS:**

Las disposiciones contenidas en los artículos 18 y 94 bis del Decreto N°100, del año 2020, del Ministerio Secretaría General de la Presidencia, que fija el texto refundido, coordinado y sistematizado de la Constitución Política de la República de Chile; en el artículo 44 del Decreto con Fuerza de Ley N°1, del año 2017, del Ministerio Secretaría General de la Presidencia, que fija el texto refundido, coordinado y sistematizado de la Ley N°20.640, que establece el Sistema de Elecciones Primarias para la Nominación de Candidatos a Presidente de la República, Parlamentarios, Gobernadores Regionales y Alcaldes; en los artículos 10 y 20 del Decreto con Fuerza de Ley N°3, del año 2017, del Ministerio Secretaría General de la Presidencia, que fija el texto refundido, coordinado y sistematizado de la Ley N°19.884, Orgánica Constitucional sobre Transparencia, Límite y Control del Gasto Electoral; el Decreto con Fuerza de Ley N°4, del año 2017, del Ministerio Secretaría General de la Presidencia, que fija el texto refundido, coordinado y sistematizado de la Ley N°18.603, Orgánica Constitucional de los Partidos Políticos; el Decreto con Fuerza de Ley N°5, del año 2017, del Ministerio Secretaría General de la Presidencia, que fija el texto refundido, coordinado y sistematizado de la Ley N°18.556, Orgánica Constitucional sobre Sistema de Inscripciones Electorales y Servicio Electoral; la Resolución G1 del 08 de enero de 2024; y demás disposiciones legales pertinentes.

**CONSIDERANDO:**

1. Que, de acuerdo con lo señalado en el inciso 5° del artículo 10 de la Ley N°19.884, en la misma fecha que la ley determina para declarar candidaturas, el Servicio Electoral publicará el máximo de aportes de origen privado permitido.



2. Que, en virtud de lo dispuesto en el inciso final del artículo 44 de la Ley N°20.640, para efectos de los límites de los aportes que constituyen financiamiento privado de las campañas, de acuerdo a lo señalado en el artículo 10 de la Ley N°19.884, las elecciones primarias se considerarán parte de la elección definitiva.

3. Que, en ese sentido, tratándose de las elecciones definitivas, el artículo 10 de la Ley N°19.884, establece que ninguna persona podrá aportar en una misma elección y a un mismo candidato las siguientes sumas:

a. En el caso de candidatos a alcalde y/o concejal *“una suma que exceda del diez por ciento del límite del gasto electoral fijado para la respectiva comuna. Si dicho porcentaje excede las doscientas cincuenta unidades de fomento, el aporte no podrá superar esta suma”*.

b. Luego, tratándose de candidatos a consejero regional, *“una suma que exceda de doscientos cincuenta unidades de fomento”*.

c. En el caso de candidatos a gobernador regional, *“una suma que exceda de trescientas quince unidades de fomento”*.

4. Que, a su vez, tratándose de aportes personales que los mismos candidatos efectúen en sus propias campañas, el inciso 7° del citado precepto legal dispone que, estos no podrán ser superiores al veinticinco por ciento del gasto electoral permitido.

5. En el caso de las candidaturas a concejales, los aportes personales que las mismas candidaturas efectúen a sus propias campañas no podrán sobrepasar el veinticinco por ciento del límite de gasto autorizado. No obstante ello, el candidato a concejal podrá financiar con aportes propios hasta cincuenta unidades de fomento, cuando el porcentaje señalado represente un valor menor a este monto.

6. Que, por su parte, el inciso final de dicho precepto establece que, ninguna persona podrá efectuar en una misma elección de alcaldes y concejales aportes por una suma superior a 1.000 unidades de fomento y superior a 2.000 unidades de fomento en el caso de una elección de gobernadores regionales y/o consejeros regionales.

7. Que, por otra parte, de conformidad con lo señalado en el artículo 20 de la Ley N°19.884, los aportantes podrán solicitar al Servicio Electoral mantener sin publicidad su identidad, tratándose únicamente de aportes menores cuyo monto no supere las 20 unidades de fomento para las candidaturas a gobernador regional y que no podrán ser, en total,



superiores a 120 unidades de fomento para un mismo tipo de elección. Asimismo, para las candidaturas a alcalde y consejero regional los aportes menores no podrán superar las 15 unidades de fomento; y tratándose de los candidatos a concejal el aporte no podrá superar las 10 unidades de fomento.

8. Que, al tenor de la Resolución G. N°1, de 08 de enero de 2024, el valor de la unidad de fomento se fijó en \$36.855,65 pesos.

9. Que, en virtud de las consideraciones expuestas, corresponderá determinar el máximo de aportes de origen privado permitido para las elecciones definitivas y eventual segunda votación, en base a los guarismos y disposiciones antes mencionadas.

#### RESUELVO:

I. **DETERMÍNASE** los máximos de aportes de origen privado permitido para las elecciones municipales y regionales, de octubre de 2024, conforme al siguiente detalle:
